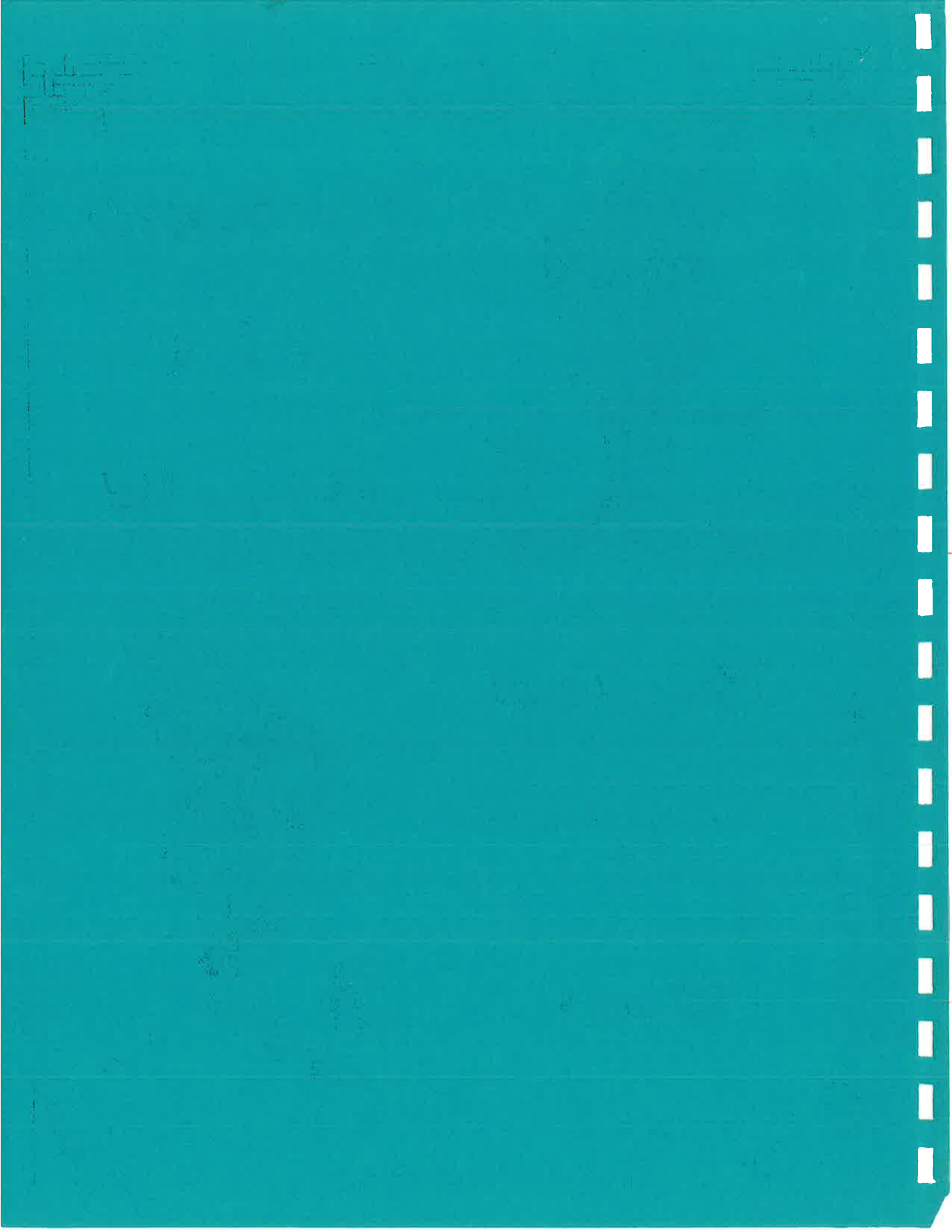

 - E. Provide refreshments for meetings.
 - F. Have frequent and informative committee reports.
 - G. Invite parents and community leaders to meetings.
 - H. The duty of the sentinel is to set up for the meeting and maintain order.
 - I. The goal of our chapter is to have 100% attendance at each and every meeting.
 - J. Have an activity after each meeting.
2. Special meetings should be held as necessary.
 - A. A special potluck dinner will be held for the Greenhand Chapter FFA Degree Installation Meeting.
 - B. A very special Awards Banquet will be held in May to wrap up the year.
3. The official ceremonies will be used at all meetings.
 - A. All officers are required to learn their part.
 - B. The officers will wear official uniform at all meetings.
 - C. The necessary paraphernalia will be used at all meetings.
4. The chapter Executive Committee will decide any action to be taken against FFA members not conducting themselves in a manner becoming to the FFA.

AIMS AND PURPOSES

The primary aim of the National FFA Organization is the development of agricultural leadership, cooperation and citizenship. The specific purposes for which this organization was formed are as follows:

1. TO DEVELOP COMPETENT AND ASSERTIVE AGRICULTURE LEADERSHIP.
2. TO DEVELOP AN AWARENESS OF THE GLOBAL IMPORTANCE OF AGRICULTURE AND ITS CONTRIBUTION TO OUR WELL-BEING.
3. TO STRENGTHEN THE CONFIDENCE OF AGRICULTURE STUDENTS IN THEMSELVES AND THEIR WORK.
4. TO PROMOTE THE INTELLIGENT CHOICE AND ESTABLISHMENT OF AN AGRICULTURAL CAREER.
5. TO STIMULATE DEVELOPMENT AND ENCOURAGE ACHIEVEMENT IN INDIVIDUAL AGRICULTURAL EXPERIENCE PROGRAMS.
6. TO IMPROVE THE ECONOMIC, ENVIRONMENTAL, RECREATIONAL AND HUMAN RESOURCES OF THE COMMUNITY.
7. TO DEVELOP COMPETENCIES IN COMMUNICATIONS, HUMAN RELATIONS AND SOCIAL ABILITIES.
8. TO DEVELOP CHARACTER, TRAIN FOR USEFUL CITIZENSHIP, AND FOSTER PATRIOTISM.
9. TO BUILD COOPERATIVE ATTITUDES AMONG AGRICULTURE STUDENTS.
10. TO ENCOURAGE WISE MANAGEMENT OF RESOURCES.
11. TO ENCOURAGE IMPROVEMENT IN SCHOLARSHIP.
12. TO PROVIDE ORGANIZED RECREATIONAL ACTIVITIES FOR AGRICULTURE STUDENTS.

The FFA Creed

I believe in the future of agriculture, with a faith born not of words but of deeds-achievements won by the present and past generations of agriculturists; in the promise of better days through better ways, even as the better things we now enjoy have come to us from the struggles of former years.

I believe that to live and work on a good farm, or to be engaged in other agricultural pursuits, is pleasant as well as challenging; for I know the joys and discomforts of agricultural life and hold an inborn fondness for those associations which, even in hours of discouragement, I cannot deny.

I believe that American agriculture can and will hold true to the best traditions of our national life and that I can exert an influence in my home and community which will stand solid for my part in that inspiring task.

THE EMBLEM

The national FFA emblem, consisting of five symbols, is representative of the history, goals and future of the organization. As a whole, the emblem covers the broad spectrum of FFA and agriculture. Each element within the emblem has unique significance. THE CROSS SECTION OF THE EAR OF CORN provides the foundation of the emblem, just as corn has historically served as the foundation crop of American agriculture. It is also a symbol of unity, as corn is grown in every state of the nation. THE RISING SUN signifies progress and holds a promise that tomorrow will bring a new day glowing with opportunity. THE PLOW signifies labor and tillage of the soil, the backbone of agriculture and the historic foundation of our country's strength. THE EAGLE is a national symbol which serves as a reminder of our freedom and ability to explore new horizons for the future of agriculture. THE OWL, long recognized for its wisdom, symbolizes the knowledge required to be successful in the industry of agriculture. The words "AGRICULTURAL EDUCATION" and "FFA" are emblazoned in the center to signify the combination of learning and leadership necessary for progressive agriculture.

FFA CHAPTER KING AND QUEEN

The Firebaugh FFA Chapter puts on the Annual F.H.S. Barn Dance every February during FFA week. The dance is open to the student body in the High School. The Chapter King and Queen are crowned at this dance.

1. Qualification for contest
 - a. Any male or female in any grade may run for king and queen, as long as they are in an ag. class.
 - b. You must really wish to represent the Firebaugh FFA Chapter at all official functions.
2. Rules and procedures
 - a. This contest is open to as many male and females who wish to be our king and queen.
 - b. Every king candidate must have a queen candidate, for the winners will be chosen by the number of tickets the pair has sold.
 - c. Every king candidate will receive a shirt. Every queen candidate will receive a shirt and a rose.
 - d. The newly crowned king and queen will receive an FFA jacket.

COMMUNITY SERVICE

To develop in FFA members an attitude of service to the community in which they live, is the objective of community service.

The chapter will develop a sense of community service among the entire membership.

- We will have a food drive for Thanksgiving and work with a church to distribute the food to the most needy in our community.
- Our chapter will collect and distribute "Toys for Tots" for Christmas.
- The chapter will set up displays in local businesses to promote our organization during FFA Week.
- Our Chapter will provide a Petting Zoo at the elementary schools in our area to acquaint these students to Agriculture.

BARN RULES

The following rules need to be followed when at the school barn.

1. The barn is open from 7:00 AM to 9:00 PM.
2. You musy follow your feeding schedule.
3. If you can not feed make sure there is some one to feed for you.
4. If you forget a feeding, the first time you will be warned the second time your animal will not be allowed to be kept at the school barn.
5. You are to work with your animal as directed by your supervisor.
6. After working with and feeding your animal you must clean the alley way in front of your animals pen.
7. Before you leave the barn make sure all the gates are closed in the barn and everything is put away.

BANK LOANS

Members of the Firebaugh FFA are able to obtain loans from the Firebaugh California Valley Bank. The following procedure should be used to obtain a loan:

1. Obtain two loan applications from the bank. You fill out one and your parents fill out the other.
2. Take the completed applications back to the bank. They will check them over for any mistakes.
3. The Ag Boosters will co-sign on the application so you are guaranteed to get the loan regardless of your financial standing.
4. The bank will contact you when your loan has been approved and tell you when your check will be ready.
5. After you pick up your check, take it to one of the Ag teachers so it can be deposited into the FFA Farm Account.

DISCIPLINE PROCEDURES DUE TO VIOLATION
OF RULES PERTAINING TO FAIRS AND SHOWS

ANY VIOLATIONS OF MANDATORY GUIDELINES OR GENERAL RULES WILL RESULT IN ONE OR MORE OF THE FOLLOWING:

- a. Serve one extra barn duty assignment.
- b. Talk to parents about the problem.
- c. Placed on probation at the next fair/show.
- d. Cannot show at the next fair.
- e. Cannot show for one calendar year.
- f. Animals are to be removed from the fair/show immediately.
- g. Pull premiums from the exhibitor.
- h. Drop exhibitor from FFA membership.
- i. Another just punishment.

GENERAL RULES AND REGULATIONS
FOR
FIREBAUGH FFA FAIR EXHIBITORS

1. All rules and regulations of the Firebaugh-Las Deltas Unified School District will apply to students who are participating at fairs.
2. Each exhibitor will be responsible for feeding and watering his/her animals during the entire fair. Any time a student is unable to attend his/her animals arrangements should be made with someone to do so along with the permission and approval of the advisor. All animals are to be fed, watered, washed, and provided with clean bedding by 8:00 AM.
3. Each student will be expected to serve Barn Duty as assigned. Barn Duty consists of:
 - a. Exhibitor on barn duty is not to leave the livestock barn area.
 - b. Keeping alleys free from straw and manure.
 - c. Removal of manure from behind Beef and Dairy cattle.
 - d. Checking to see that cattle are tied properly and hog and sheep pens are latched securely.
 - e. Any other duties that may be assigned by the FFA advisor or FFA area chairman.
 - f. Exhibitors are expected to eat lunch/dinner prior to or following barn duty.
4. FFA members will be required to wear an official FFA uniform while showing his/her animals or while helping another member exhibit animals.
5. Where dormitories are provided all members must sleep in the dorms. Bed check will be made at 11:00 PM each night except 12:00 AM Saturday night. Exhibitors not accounted for may be sent home.
6. Where dormitories are not provided, all members must sleep at home and should be off the fairgrounds and out of the parking lot and away from the fair by 11:00 PM each night, with the exception of 12:00 AM midnight on Saturday night.
7. Premium money checks will be handed out to the exhibitors after thank-you letters have been turned in to the advisor after the fair.

8. FFA members are expected to have advance excuses from school classes, issued by the Ag. Instructor and signed by all their teachers for the days that they will be missing from school. Those without excuses are expected to be in school.
9. Each exhibitor should read the rules and regulations that are published in the fair's premium book.
10. Smoking, Profanity, or misconduct around the livestock area by exhibitors will not be tolerated.
11. All Firebaugh FFA exhibitors are expected to attend the awards program at every fair.
12. All medications administered to show animals must be cleared with the advisor prior to using them.
13. Feed pans are not to be left in front of the animals or in pens during the fair.
14. Before a student is issued an excuse for the fair, the above rules and regulations must be read and signed by an FFA exhibitor and his parents.
15. Please have your son/daughter return this form to school signed in the space provided below.
