2. TO DEVELOP AN AWARENESS OF THE GLOBAL IMPORTANCE OF AGRICULTURE AND ITS CONTRIBUTION TO OUR WELL-BEING.
3. TO STRENGTHEN THE CONFIDENCE OF AGRICULTURE STUDENTS IN THEMSELVES AND THEIR WORK.
4. TO PROMOTE THE INTELLIGENT CHOICE AND ESTABLISHMENT OF AN AGRICULTURAL CAREER.
5. TO STIMULATE DEVELOPMENT AND ENCOURAGE ACHIEVEMENT IN INDIVIDUAL AGRICULTURAL EXPERIENCE PROGRAMS.
6. TO IMPROVE THE ECONOMIC, ENVIRONMENTAL, RECREATIONAL AND HUMAN RESOURCES OF THE COMMUNITY.
7. TO DEVELOP COMPETENCIES IN COMMUNICATIONS, HUMAN RELATIONS AND SOCIAL ABILITIES.
8. TO DEVELOP CHARACTER, TRAIN FOR USEFUL CITIZENSHIP, AND FOSTER PATRIOTISM.
9. TO BUILD COOPERATIVE ATTITUDES AMONG AGRICULTURE STUDENTS.
10. TO ENCOURAGE WISE MANAGEMENT OF RESOURCES.
11. TO ENCOURAGE IMPROVEMENT IN SCHOLARSHIP.
12. TO PROVIDE ORGANIZED RECREATIONAL ACTIVITIES FOR AGRICULTURE STUDENTS.

The FFA Creed

I believe in the future of agriculture, with a faith born not of words but of deeds-achievements won by the present and past generations of agriculturists; in the promise of better days through better ways, even as the better things we now enjoy have come to us from the struggles of former years.

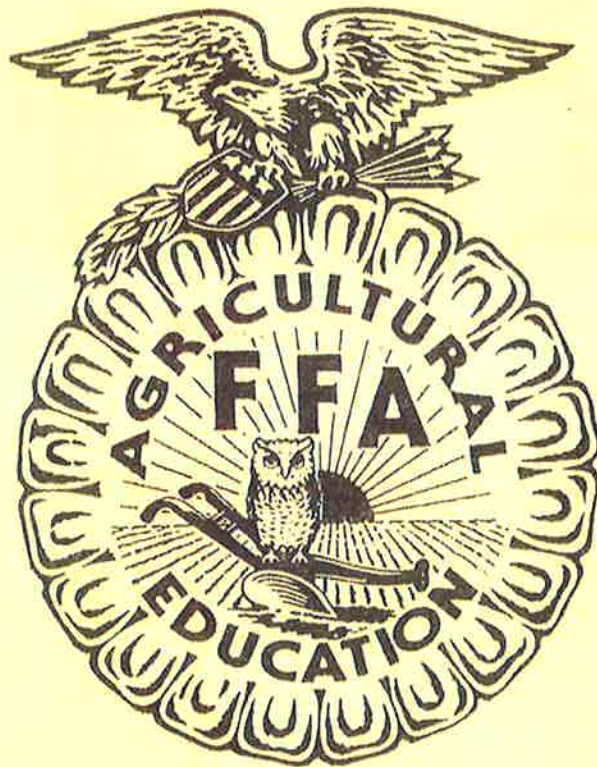
I believe that American agriculture can and will hold true to the best traditions of our national life and that I can exert an influence in my home and community which will stand solid for my part in that inspiring task.

The creed was written by E. M. Tiffany, and adopted at the 3rd National Convention of the FFA. Revised at the 38th Convention and the 63rd Convention.

THE EMBLEM

The national FFA emblem, consisting of five symbols, is representative of the history, goals and future of the organization. As a whole, the emblem covers the broad spectrum of FFA and agriculture. Each element within the emblem has unique significance. THE CROSS SECTION OF THE EAR OF CORN provides the foundation of the emblem, just as corn has historically served as the foundation crop of American agriculture. It is also a symbol of unity, as corn is grown in every state of the nation. THE RISING SUN signifies progress and holds a promise that tomorrow will bring a new day glowing with opportunity. THE PLOW signifies labor and tillage of the soil, the backbone of agriculture and the historic foundation of our country's strength. THE EAGLE is a national symbol which serves as a reminder of our freedom and ability to explore new horizons for the future of agriculture. THE OWL, long recognized for its wisdom, symbolizes the knowledge required to be successful in the industry of agriculture. The words "AGRICULTURAL EDUCATION" and "FFA" are emblazoned in the center to signify the combination of learning and leadership necessary for progressive agriculture.



FFA MOTTO AND COLORS

COLORS

As the blue field of our nation's flag and the golden fields of ripened corn unify our country, the FFA colors of NATIONAL BLUE and CORN GOLD give unity to the organization. All FFA functions and paraphernalia should proudly display the colors.

MOTTO

Our motto consists of only four lines filled with practical philosophy, reflecting a spirit and sincerity of youth, the backbone of our nation. The FFA motto gives members twelve short words to live by as they experience the opportunities in the organization. The FFA Motto is:

Learning to do

Doing to learn

Earning to live

Living to serve

PROPER USE OF FFA JACKET & THE OFFICIAL DRESS

1. The jacket is to be worn only by members.
2. The jacket should be kept clean and neat.
3. The jacket should have only a large emblem on the back and a small emblem on the front. It should carry the name of the State Association and the name of the local chapter, district or area on the back and the name of the individual and one office or honor on the front.
4. The jacket should be worn on official occasions with the zipper fastened to the top. The collar should be turned down and the cuffs buttoned.
5. The jacket should be worn by members and officers on all official FFA occasions, as well as other occasions where the chapter or state association is represented. It may be worn to school and other appropriate places.
6. The jacket should only be worn to places that are appropriate for members to visit.
7. School letters and insignia of other organizations should not be attached to or worn on the jacket.
8. When the jacket becomes faded and worn, it should be discarded or the emblems and lettering should be removed.
9. The emblems and lettering should be removed if the jacket is given or sold to a non-member.
10. A member always acts like a lady or gentleman when wearing the jacket.
11. Members should refrain from use of tobacco and alcohol while wearing the FFA jacket or officially representing the organization.
12. All chapter degrees, offices, and award medals should be worn beneath the name on the right side of the jacket, with the exception that a single State FFA Degree charm or American FFA Degree Key should be worn above the name or attached to a standard key chain. No more than three medals should be worn on the jacket. These should represent the highest degree earned, the highest office held and the highest award earned by the member.

OFFICIAL FFA DRESS

The official dress for female members is to be a black skirt of length or longer, white blouse with official FFA blue scarf, black shoes, nylons of neutral color, and official jacket zipped to the top. Black slacks may be worn for outdoor activities, such as judging, excessive traveling and camping.

The official dress for male members is to be black slacks, white dress shirt, blue FFA tie, black shoes and socks and the official jacket zipped to the top.

CONDUCT OF MEETINGS

1. Hold regular meetings that are well-planned for general chapter interest and participation.
 - A. Have regular monthly chapter meetings or activities.
 - B. Call special meetings when necessary.
 - C. Conduct regular executive committee meetings in order to maintain solid chapter communication.
 - D. Prepare well-planned programs before meetings.
 - E. Provide refreshments for meetings.
 - F. Have frequent and informative committee reports
 - G. Invite parents and community leaders to meetings.
 - H. The duty of the sentinel is to set up for the meeting and maintain order.
 - I. The goal of our chapter is to have 100% attendance at each and every meeting.
 - J. Have an activity after each meeting.
2. Special meetings should be held as necessary.
 - A. A special potluck dinner will be held for the Greenhand/Chapter FFA Degree Installation Meeting .
 - B. A very special Awards Banquet will be held in May to wrap up the year.
3. The official ceremonies will be used at all meetings.
 - A. All officers are required to learn their part.
 - B. The officers will wear official uniform at all meetings.
 - C. The necessary paraphernalia will be used at all meetings.
4. The chapter Executive Committee will decide any action to be taken against FFA members not conducting themselves in a manner becoming to the FFA.

FFA CHAPTER SWEETHEART

Our Firebaugh FFA Chapter puts on the annual FHS Barn Dance every February during FFA week. It is an activity that is open to the student body in the high school. The Firebaugh Chapter has a professional D. J. and the Chapter Sweetheart is crowned at this event.

The following rules have been revised for those girls interested in running for Chapter Sweetheart.

1. Qualifications contest:
 - a. Any girl who is an Ag class.
 - b. Must have a sincere desire to represent the chapter at all official functions.
 - c. Any grade level may participate in this contest.
2. Rules and procedures
 - a. Only four (4) candidates, representing each class, are eligible to run for Queen. If more than four (4) girls apply, then by a secret ballot the FFA members will select the finalist.
 - b. Each finalist will receive roses and a gift certificate.
 - c. The newly crowned Chapter Sweetheart will receive roses, a crown, a gift certificate and a white FFA Chapter Sweetheart Jacket.
 - d. The Chapter Sweetheart will be selected on the basis of ticket sales.

COMMUNITY SERVICE

To develop in FFA members an attitude of service to the community in which they live, is the objective of community service.

The chapter will develop a sense of community service among the entire membership.

- We will have a food drive for Thanksgiving and work with a church to distribute the food to the most needy in our community.
- Our chapter will collect and distribute "Toys for Tots" for Christmas.
- We will go Christmas Carolling at the Senior Citizens Center in Firebaugh.
- The chapter will set up displays in local businesses to promote our organization during FFA Week.
- Our Chapter will provide a Petting Zoo at the elementary schools in our area to acquaint these students to Agriculture.

BARN RULES

The following rules need to be followed when at the school barn.

1. The barn is open from 7:00 AM to 9:00 PM.
2. You musy follow your feeding schedule.
3. If you can not feed make sure there is some one to feed for you.
4. If you forget a feeding, the first time you will be warned the second time your animal will not be allowed to be kept at the school barn.
5. You are to work with your animal as directed by your supervisor.
6. After working with and feeding your animal you must clean the alley way in front of your animals pen.
7. Before you leave the barn make sure all the gates are closed in the barn and everything is put away.

GENERAL RULES AND REGULATIONS
FOR
FIREBAUGH FFA FAIR EXHIBITORS

1. All rules and regulations of the Firebaugh-Las Deltas Unified School District will apply to students who are participating at fairs.
2. Each exhibitor will be responsible for feeding and watering his/her animals during the entire fair. Any time a student is unable to attend his/her animals arrangements should be made with someone to do so along with the permission and approval of the advisor. All animals are to be fed, watered, washed, and provided with clean bedding by 8:00 AM.
3. Each student will be expected to serve Barn Duty as assigned. Barn Duty consists of:
 - a. Exhibitor on barn duty is not to leave the livestock barn area.
 - b. Keeping alleys free from straw and manure.
 - c. Removal of manure from behind Beef and Dairy cattle.
 - d. Checking to see that cattle are tied properly and hog and sheep pens are latched securely.
 - e. Any other duties that may be assigned by the FFA advisor or FFA area chairman.
 - f. Exhibitors are expected to eat lunch/dinner prior to or following barn duty.
4. FFA members will be required to wear an official FFA uniform while showing his/her animals or while helping another member exhibit animals.
5. Where dormitories are provided all members must sleep in the dorms. Bed check will be made at 11:00 PM each night except 12:00 AM Saturday night. Exhibitors not accounted for may be sent home.
6. Where dormitories are not provided, all members must sleep at home and should be off the fairgrounds and out of the parking lot and away from the fair by 11:00 PM each night, with the exception of 12:00 AM midnight on Saturday night.
7. Premium money checks will be handed out to the exhibitors after thank-you letters have been turned in to the advisor after the fair.

8. FFA members are expected to have advance excuses from school classes, issued by the Ag. Instructor and signed by all their teachers for the days that they will be missing from school. Those without excuses are expected to be in school.
9. Each exhibitor should read the rules and regulations that are published in the fair's premium book.
10. Smoking, Profanity, or misconduct around the livestock area by exhibitors will not be tolerated.
11. All Firebaugh FFA exhibitors are expected to attend the awards program at every fair.
12. All medications administered to show animals must be cleared with the advisor prior to using them.
13. Feed pans are not to be left in front of the animals or in pens during the fair.
14. Before a student is issued an excuse for the fair, the above rules and regulations must be read and signed by an FFA exhibitor and his parents.
15. Please have your son/daughter return this form to school signed in the space provided below.

DISCIPLINE PROCEDURES DUE TO VIOLATION
OF RULES PERTAINING TO FAIRS AND SHOWS

ANY VIOLATIONS OF MANDATORY GUIDELINES OR GENERAL RULES WILL RESULT IN ONE OR MORE OF THE FOLLOWING:

- a. Serve one extra barn duty assignment.
- b. Talk to parents about the problem.
- c. Placed on probation at the next fair/show.
- d. Cannot show at the next fair.
- e. Cannot show for one calendar year.
- f. Animals are to be removed from the fair/show immediately.
- g. Pull premiums from the exhibitor.
- h. Drop exhibitor from FFA membership.
- i. Another just punishment.

OFFICIAL SHOW UNIFORM

The official show uniform for FFA members includes: White shirt or blouse, white pants, FFA tie/scarf and the FFA jacket. Instead of the jacket an official FFA emblem may be worn on your white shirt or blouse. Shoes should be appropriate for what you are showing.

The Firebaugh FFA Chapter is in many fairs throughout the year. The livestock and Ag mechanics projects are exhibited throughout the state, where the chapter members win many awards and honors. The animals that are exhibited include market and breeding sheep, market and breeding beef, marketing and breeding swine, dairy cows, rabbits and goats. Students may also exhibit Ag mechanics projects, ornamental horticulture projects, and crop projects at these fairs.

BANK LOANS

Members of the Firebaugh FFA are able to obtain loans from the Firebaugh California Valley Bank. The following procedure should be used to obtain a loan:

1. Obtain two loan applications from the bank. You fill out one and your parents fill out the other.
2. Take the completed applications back to the bank. They will check them over for any mistakes.
3. The Ag Boosters will co-sign on the application so you are guaranteed to get the loan regardless of your financial standing.
4. The bank will contact you when your loan has been approved and tell you when your check will be ready.
5. After you pick up your check, take it to one of the Ag teachers so it can be deposited into the FFA Farm Account.
